R+T Asia Buyer Club: Terms & Conditions

Terms and Conditions for Membership in the R+T Asia Buyer Club

(International club for trade visitors of R+T Asia, the trade show organized by GLOBUS Events Limited and Landesmesse Stuttgart GmbH & Co. KG)

(As of December 2025)

1. Scope of application

- a. The services provided by **R+T Asia** (hereinafter referred to as **Organizer**) in relation to membership in the **R+T Asia Buyer Club** (hereinafter referred to as the **RTBC**) shall be subject to the following membership conditions. By completing the registration process, the member accepts these terms and conditions of use.
- b. Membership in the RTBC is only open to natural persons who are leading decision-makers (e.g., managing directors, shareholders, board members, proprietors, managers) purchase managers, business developers (managers for the strategic and operative development of a company relating to new products) and multipliers (visitors whose significant role in the industry makes their presence critical for other exhibitors or visitors). Eligible members are from high-revenue companies or market leaders in industries relevant to the event within their respective countries. Members represent professional groups such as manufacturers, distributors/wholesalers, agents, import/export traders, and retail chains within the sun shading and door/gate industry.
- c. Membership in the RTBC is free of charge.

2. Registration

- a. Membership in the RTBC must be applied for online in advance. As part of the online registration, personal data (e.g., company name, individual's name, address, email address, phone number) will be collected in compliance with the statutory data protection provisions.
- b. The member undertakes to provide all required company and personal information completely and truthfully. Any subsequent changes must be promptly communicated to the Organizer's team by sending an email to rtbc@globusevents.com
- c. The Organizer reserves the right to deny membership applications. The amount of members is limited.
- d. Following registration, the Organizer determine whether the applicant meets the target group definition provided above. The applicant will receive an email confirming whether membership in the RTBC has been approved or denied, either because the applicant does not qualify as a trade visitor or the membership limit has been reached.

- e. During the registration process, the Organizer will inquire about the applicant's interest in specific products, which must be specified in detail. This information will guide the selection of exhibitors for the Business Matching Event. Based on this, the Organizer will invite suitable exhibitors to present their offerings.
- f. By registering, the member acknowledges the event-related special provisions.

3. Services

- a. The RTBC offers the following services, subject to availability during the respective event:
 - i. A 3-night stay in a 5-star hotel near the venue (breakfast included).
 - ii. Dedicated check-in counter, pre-printed badges, a welcome gift, and VIP gate access to the show.
 - iii. Access to the exclusive Buyer Club Lounge, offering coffee, soft drinks, lunch sets, comfortable seating, and free Wi-Fi throughout the 3-day event.
 - iv. Participation in the Business Matching Event, where exhibitors present their offers in a speed-dating format based on Buyer Club members' product interests.
 - v. An invitation to the VIP International Party, providing an opportunity to network with industry peers and professionals like yourself.
- b. The RTBC program offers a limited number of spots and is designed to include a diverse range of companies eligible for membership. Each company is entitled to complimentary accommodation for one member. Additional professionals from the same company may be considered on a case-by-case basis.
- c. Access to the Buyer Club Lounge is reserved for members with a special Hosted Buyer badge, which is issued upon presenting the Buyer Club code and visitor registration ticket at the entrance.
- d. Members may bring one event visitor as a companion into the lounge. Companions must hold a valid event ticket and may only stay in the lounge when accompanied by the member. Companions enjoy free catering, excluding lunch sets reserved for Buyer Club members. Other benefits are exclusive to members.
- e. **Buyer Club Booth Tour***

As part of the exclusive RTBC benefits, all members will now participate in the **Buyer Club Booth Tour**, scheduled on the first day of the show in the morning (approximately 1–1.5 hours).

- **Participation** in the Booth Tour on the first day of the show (morning, approx. 1-1.5 hours) is **mandatory for all members**.
- Buyers will be grouped based on their product preferences selected during the application process.
- Each group will visit 6-8 exhibitor booths for exclusive introductions and insights.
- Detailed instructions will be provided before the show.

Flexibility for the Rest of the Show: Apart from the Booth Tour, RTBC members are free to explore the exhibition, schedule meetings, and manage their time according to their own agenda.

- f. To attend the VIP International Party, members must confirm participation via email at rtbc@globusevents.com or at dominika.karwala@globusevents.com within the indicated deadline. Only confirmed attendees will receive invitations in their welcome packages.
- g. RTBC services are exclusively for members and may not be transferred to third parties. No claims for compensation or payouts are permitted. The Organizer reserves the right to limit or discontinue services at any time.

4. Termination of Membership

- a. Membership is suspended if the member simultaneously participates as an exhibitor at the event.
- b. Membership is evaluated annually and assigned for each event edition. The Organizer reviews whether the member meets the target group definition. Membership is not automatically extended.
- c. The Organizer may terminate membership immediately under the following circumstances:
 - i. Membership criteria are not or no longer met
 - ii. False information was provided during registration
 - iii. The member has violated these terms and conditions
 - iv. The member did not attend Business Matching Event
 - v. Membership continuation is deemed unacceptable by the Organizer
- d. Members unable to attend must notify the Organizer immediately via email at rtbc@globusevents.com to allow waitlisted candidates to join. Failure to notify will result in exclusion from future events.

5. Member Obligations, Prohibition of Sales and Advertising

- a. Members must immediately inform the Organizer if membership data is misused by third parties.
- b. Advertising, offering goods/services, or conducting opinion polls by the members during the exhibition is prohibited without prior Organizer approval. Violations may result in membership termination and denial of event access.
- c. Members are required to attend the Business Matching Event.

6. Audio and Video Recordings

Members consent to the Organizer or a third party creating and using audiovisual recordings of their participation, free of charge, for promotional purposes related to RTBC and R+T Asia trade show.

7. Liability

- a. The Organizer is not liable for defects in free services or information provided unless resulting from gross negligence or intent.
- b. The Organizer expressly distances itself from the content of third-party websites, which have direct or indirect links to RTBC. The Organizer is not liable for these contents and websites. Only the providers of the respective websites are responsible for the content of these websites.

8. Changes to the Terms and Conditions of Use

Changes to these terms, particularly those necessitated by legal requirements, will be communicated via email or newsletter. They will be deemed accepted unless the member objects within 14 days. The Organizer reserves the right to terminate membership if an objection is received.
