Terms and Conditions for Membership 2026 R+T Asia Buyer Club

International club for professional trade show visitors of R+T Asia,
organized by GLOBUS Events Limited and Landesmesse Stuttgart GmbH & Co. KG

1. Scope of Application

1.1

These Terms and Conditions govern the services provided by R+T Asia (hereinafter referred to as the **Organizer**) in connection with membership in the R+T Asia Buyer Club (hereinafter referred to as the **RTBC**). By completing the registration process, the applicant accepts these Terms and Conditions.

1.2

RTBC membership is open exclusively to **natural persons** who are **senior decision-makers**, such as managing directors, shareholders, board members, proprietors, managers, purchasing managers, and business developers, as well as industry multipliers **whose professional influence is of strategic relevance to the event**.

Eligible members must represent **mid- or large-size companies or market leaders in industries relevant to R+T Asia** within their respective countries. Professional backgrounds may include manufacturers, distributors/wholesalers, agents, import/export traders, and retail chains within the **sun shading and door/gate industries**.

1.3

RTBC membership is **free of charge** for approved members.

2. Registration

2.1

Applications for RTBC membership must be submitted **online in advance**. During registration, personal and company-related data (such as company name, individual name, address, email address, and phone number) will be collected in accordance with applicable data protection laws.

2.2

Applicants are required to provide all requested information **completely and truthfully**. Any subsequent changes must be communicated promptly to the Organizer by email to dominika.karwala@globusevents.com.

2.3

The Organizer reserves the right to **reject membership applications** at its sole discretion. The number of RTBC members is limited.

2.4

After registration, the Organizer will assess whether the applicant meets the defined target group criteria. **Only selected applicants will receive a qualification confirmation email.**

Final confirmation of membership requires the applicant to submit:

- A copy of their travel itinerary confirming arrival in Shanghai **no later than May 26, 2026**, and
- Confirmation of participation in the **Buyer Club Booth Tour on May 27, 2026**, together with all RTBC members.

2.5

During registration, applicants must specify their **product interests in detail**. This information will be used to design a guided and customized Booth Tour and to select suitable exhibitors for participation.

2.6

By registering, members acknowledge and accept all event-specific regulations.

3. Services

3.1

Subject to availability, RTBC members are entitled to the following services during the event:

- **Three (3) nights' accommodation** in a 4-star hotel near the exhibition venue, including breakfast
- **Dedicated check-in counter**, pre-printed badge, welcome gift, and VIP gate access
- Access to the **International Buyer Lounge**, including coffee, soft drinks, lunch sets, comfortable seating, and free Wi-Fi throughout the three-day event
- Invitation to the **VIP International Party**, offering networking opportunities with international industry professionals
 - Participation must be confirmed by email to dominika.karwala@globusevents.com within the stated deadline
 - Only confirmed participants will receive an invitation in their welcome package
- **Buyer Club Booth Tour**
 - Scheduled on the **first day of the show (morning)** and lasting approximately **1–1.5 hours**
 - Participation is **mandatory** for all RTBC members
 - Members will be grouped according to product interests stated during registration
 - Each group will visit **6–8 selected exhibitor booths** for exclusive presentations
 - Detailed instructions will be provided prior to the event

3.2

RTBC membership is limited and designed to ensure a balanced and diverse group of companies. **Each company which applies to the program is entitled to one complimentary accommodation** for one approved member. Additional participants from the same company may be considered on a case-by-case basis.

3.3

Access to the **International Buyer Lounge** is limited to members holding a **VIP Buyer badge**, issued upon presentation of the Buyer Club code and a valid visitor registration ticket.

3.4

Members may bring **one accompanying visitor** into the lounge. Companions must hold a valid event ticket and may only enter the lounge when accompanied by the member. Complimentary catering is provided, excluding lunch sets, which are reserved for RTBC members. All other benefits are exclusive to members.

3.5

Except for the mandatory Booth Tour, members are free to organize their schedules independently and explore the exhibition according to their own agendas.

3.6

RTBC services are **non-transferable** and exclusively reserved for approved members. No compensation or cash payments may be claimed. The Organizer reserves the right to modify, limit, or discontinue services at any time.

4. Termination of Membership

4.1

Membership will be **suspended** if the member participates in the event as an exhibitor.

4.2

RTBC membership is evaluated **annually** and applies only to the respective event edition. Membership is **not automatically renewed**.

4.3

The Organizer may terminate membership with immediate effect if:

- Membership criteria are not or are no longer fulfilled
- False or misleading information was provided during registration
- These Terms and Conditions are violated
- The member fails to attend the mandatory Business Matching or Booth Tour
- Continued membership is deemed unacceptable by the Organizer

4.4

Members who are unable to attend must notify the Organizer immediately by email to dominika.karwala@globusevents.com. Failure to do so may result in exclusion from future RTBC programs.

5. Prohibition of Sales Activities

Advertising, sales activities, service offerings, or opinion polling during the event are strictly prohibited without prior written approval from the Organizer. Violations may result in immediate termination of membership and denial of event access.
